
Ten-Minute Training Topics Release Calendar

What is Included?

Each month, we send a driver handout (includes a small "poster" to reinforce key issues from the handout) and a "How To" guide for managers. The "How To" guide provides suggestions on creative ways to distribute the topics or conduct short discussions with drivers.

From time to time, we also include a "Managers Supplement" – this provides additional information on that month's topic and points out areas that a management team may need to develop policies in support of crash prevention.

Frequently Asked Questions

- Q. Can I share these with family members?
- A. Absolutely. Many of the topics apply to how we drive our personal cars, too!
- Q. Can I share these with other companies?
- **A.** We provide the training topics to you for your participation in our "Safety Hotline Service" or our "OSCER System" database other companies who are not members should not be given these documents; however, they may purchase a subscription to the topics program.
- Q. How do I access the Technical Library at "My SafetyFirst"?
- **A.** If you do not have your ID or Password to access our web site, call us with your company name and contact information (for confirmation purposes) and we will get you set up right away!
- Q. Do you have these topics for Workers Compensation, Fire Safety and other areas?
 A. We did produce a topic on "Falls", and we may produce others on related safety topics we ultimately work on topics based on client suggestions, so let us know what you need!
- Q. What about languages other than English?
- **A.** We did produce a topic in Spanish, but got very little response from that test. At the present time we are not translating our Topics into French-Canadian or Spanish, but will consider doing so if there is enough demand to justify the extra expense.
